

## Club Dining Membership FAQ's

**Q: What is a Club Dining Membership?**

*A: A Club Dining Membership provides full use of the Dining Room, Patio and Banquet Rooms – Travis Room & McInnis Hall. (Note: 19<sup>th</sup> Hole Bar Lounge is restricted to Members Only)*

**Q: Are there any golf privileges with a Club Dining Membership?**

*A: No, there are no golfing or range privileges with this type of membership.*

**Q: Can I golf as a guest of a member?**

*A: Yes, you may golf as a guest of a member, upon payment of a green fee, once per month to a maximum of 7 rounds per season.*

**Q: Are there any food & beverage minimums with a Club Dining Membership?**

*A: No, there are no spending requirements.*

**Q: Can I have account privileges to pay for my meal(s)?**

*A: No. Club Dining members do not have the ability to charge to a house account, all payments must be made at the time of your visit (i.e. cash, debit, Visa or Master card).*

**Q: How long is the Club Dining Membership valid?**

*A: The membership is valid for one season (the time of purchase until clubhouse closing date). A package will be sent out in November should you wish to continue for another season, payment of the annual membership fee would be required.*

**Q: Can I book special events in the Banquet Rooms?**

*A: Yes, you can book any event through our Banquet Department and our Professional Team will review the various menus and details to make you event a success.*

**Q: Is there any restrictions on when I can use my membership during the Season?**

*A: Club Diners can use their membership at any time with the ONLY exception of Thursday's Evenings.*

**Q: Are reservations required when using the Dining Facilities?**

*A: Yes, reservations are mandatory for dining during the hours of 4:00pm to close by calling 905-892-2638 Ext. 243.*

**Q: Can I make purchases from the Club's Golf Shop?**

*A: Yes, as a Club Dining Member you can make purchases from of our member Golf Shop at any time. Payment methods accepted for Club Dining are debit, visa or master card.*

**Q: Is there a Dress Code when using the Dining Facilities?**

*A: Yes, there is a dress code in effect at all times. Please refer to the Club's Dress Code for details.*

## Dress Code

*(Revised 2018)*

1. The Dress Code term “smart casual” should be considered as a minimum standard of dress at the Club at all times. The Dress Code will apply equally to all members and guests regardless of age.
2. Footwear is required at all times in the Clubhouse. Sport-sandals such as flip flops or Crocs are not permitted in the Dining Room. Dress sandals for both men and women are permitted in the outdoor service areas of the Clubhouse as well the 19<sup>th</sup> Hole and Dining Room.
3. Appropriate denim apparel is permitted in the Dining Room, Patio, and the 19th Hole. Cut off jeans, jeans that are torn, ripped, frayed or patched are NOT permitted anywhere on the property. Denim wear of any colour is not permitted at any time on the Golf Course or the Practice Range.
4. See-through shirts, midriff-baring shirts, tank tops, tube tops, halter tops, logo t-shirts (not adhering to the 4-inch rule), jogging/rugby pants, spandex wear, short shorts, tights, yoga pants, or short skirts are not acceptable on the property (including the Practice Range) or in the Clubhouse. Non-LPCC logos are permissible if the logo is smaller than 4” x 4”.
5. Wearing pants or shorts noticeably below waist height is not acceptable.
6. Golf hats, caps, or visors are permitted in the Golf Shop, Patio, 19<sup>th</sup>Hole and on the Golf Course. All head wear is to be worn as it is intended (bill forward).

The Club realizes that members use the Club in certain areas while they are in transition. Members are permitted to enter and exit the Club (Clubhouse entrance to locker rooms only) in street attire. Changing from street attire to acceptable Club standard is NOT permitted in the parking lot.

Finally, the Club makes every effort to ensure that all clothing sold in the Golf Shop complies with the Dress Code as amended from time to time. All Management and Staff will make every effort to advise the member or guest when they are in violation of the Dress Code. However, the responsibility for compliance is ultimately the responsibility of the member and not any LPCC Staff or Management.

### Golfers Dress Code

1. Tailored shorts for men are to be of conservative length worn at the knee. Shorts, skirts, skorts, or golf dresses for women are permitted.
2. Pants/Shorts with draw strings and cargo shorts/pants are not permissible.
3. No denim apparel of any colour is allowed on the Golf Course or Practice Range at any time.
4. Metal spiked golf shoes are not permitted anywhere on the Club’s property.
5. Clothing with non-LPCC logos are permissible, if the logo is smaller than 4” x 4”.
6. Caps and visors may not be worn backwards at any time.
7. When wearing shorts, socks or sockettes are required with all footwear on the Golf Course except golf sandals, which do not require socks.

### **Ladies and Junior Girls**

1. Sleeveless golf shirts / blouses must have a collar and collarless shirts/blouses must have sleeves.
2. Shirts must be tucked in unless they have been specifically tailored to be worn otherwise.
3. Capri pants and wind suits are permitted.
4. Women's designer golf apparel is allowed.
5. Ladies attending the Club for non-golf activities are permitted to wear presentable dresses, sleeveless tops without collars or collarless tops without sleeves.

### **Gentlemen and Junior Boys**

1. Collared golf shirts, turtlenecks, or mock neck shirts with a collar of at least 1½" are acceptable and must be tucked in at all times.
2. Wind suits are permitted.

## **Rules of the Club**

### **Clubhouse:**

- 1) Children under the age of 10 must be supervised by an adult while on Club property.
- 2) Members are requested to respect others and refrain from loud & disrespectful behavior at all times.
- 3) Members must sign all chits associated with the purchase of goods & services placed on account.
- 4) Members may not enter the kitchen, pantries, or staff areas, unless accompanied by Management.
- 5) Smoking is not permitted in any areas of the clubhouse.

### **Cell Phone, Blackberry and other P.D.A./Mobile device Policy**

1. All mobile and cellular devices are to be switched to silent or vibrate mode while on Club property.
2. Members are expected to use common courtesy when using mobile and cellular devices on the course and in the Clubhouse for email or texting purposes.
3. UNDER NO CIRCUMSTANCES should the use of these devices interfere with the pace of play, the play of other members or the enjoyment of other members and guests.
4. UNDER NO CIRCUMSTANCES is the use of a mobile phone or other electronic device with a camera for any reason permitted in the Locker Rooms.

### **LLBO:**

The Liquor Laws of the Province of Ontario govern members, guests and visitors. Any questions regarding these laws as applicable to Club premises should be directed to management.

Any member, guests, or visitors will indemnify the Club if the Club suffers any penalty or liability for any breach of the Liquor Laws.

House staff is trained in Smart Serve and reserves the right to limit or curtail the service of alcoholic beverages. The Club has adopted a policy regarding the consumption of liquor which complies with requirements of the LLBO. Copies are posted in the Clubhouse.
