A 2.5% Administration Fee will be applicable to ALL payments or purchases made with a credit card. These include the Pre-Authorized Payment Option, Annual Membership Dues, Entry fees, and Point of Sale Purchases

APPLICATION AGREEMENT:

1. **CORPORATE MEMBERS MUST BE AN OFFICER, OWNER, DIRECTOR OR EMPLOYEE OF THE CORPORATION.**
2. **CORPORATE MEMBERS MUST BE 21 YEARS OF AGE OR OLDER.**
3. **CORPORATE ENTRY FEE WILL COVER UP TO FOUR MEMBERS ON ACCOUNT. A CORPORATE DESIGNATE CHANGE FEE WILL APPLY EACH TIME A MEMBER IS EXCHANGED FOR A NEW MEMBER.**
4. **THE CORPORATION WILL BE REGISTERED AS THE ACCOUNT HOLDER AND THE PRIMARY MEMBER ON THE ACCOUNT WILL HAVE FULL RESPONSIBILITY FOR ALL CHARGES INCURRED UNLESS SPECIFIED DIFFERENTLY. ACCOUNTS SHALL BE SETTLED IN ACCORDANCE WITH THE CLUB RULES & REGULATIONS WITHIN 30 DAYS OF THE STATEMENT DATE.**
5. **THE CORPORATION SHALL BE ENTITLED TO ONE CLASS "B" VOTING SHARE ONCE THE ENTRY FEE IS PAID IN FULL AND WILL BE ASSIGNED TO THE PRIMARY MEMBER.**
6. **MEMBERSHIP PROVIDES A MEMBER WITH ACCESS TO THE GOLF COURSE AND CLUBHOUSE DURING OPERATIONAL MONTHS. THE CLOSURE OF ANY PART OF THE GOLF COURSE AND/OR CLUBHOUSE FOR REPAIR, MAINTENANCE, IMPROVEMENTS, AND CORPORATE EVENTS OR OTHERWISE SHALL BE PERMITTED AT THE SOLE DISCRETION OF THE BOARD OF DIRECTORS.**
